1. Acceptance of Terms

The reservation percentages and date of reservations are completely dependent on the sellers point. Mobicile will not be liable to deduction of market prices after the reservation is done.
- 4.2. All listings must comply with Mobicile's policies and applicable laws.

5. Reservation-Only Model

- 5.1. Buyers may reserve items without full upfront payment. You agree to honor these reservations in accordance with the terms outlined on the platform.

6. Payment Holding System

- 6.1. Payments made by buyers will be held securely until you complete the order. You agree to fulfill orders promptly and communicate any issues that may arise.

7. Order Completion Code

- 7.1. You will receive a unique order completion code for each transaction, which must be provided to the buyer upon completion of the order.

8. User Behavior Tracking

- 8.1. Mobicile may track user behavior to enhance engagement and satisfaction on the platform. By using Mobicile, you consent to such tracking.

9. Communication with Buyers

- 9.1. You may communicate directly with buyers through the basic chat system provided on Mobicile for discussing reservations and item details.
